

**H&A OUTFITTERS, INC.
FULLY GUIDED HUNT CONTRACT**

A \$500 non-refundable deposit is required to book a limited draw hunt with H&A Outfitters, Inc. This deposit will be subtracted from the total hunt cost when we have successfully drawn a tag on your behalf through our License Application Service. At that time 50% of the balance of your hunt cost will be due within 15 days of draw results. The total remaining balance is due 60 days prior to your hunt date. All deposits and payments are non-refundable. **All 1 x 1 hunters will be charged an additional \$300 per day. This charge will be added to your invoice. Your total hunt cost is fixed. Once you tag out, our obligation has been met. There are no refunds. All hunts are free ranging fair chase.**

HUNT POLICIES: Wounded animals: We will make every effort to locate your wounded trophy. It will be the outfitter's decision if your hunt will resume and if so, there will be a \$1,000 cash charge. **Rifle and muzzle loader hunters:** If you have had ample opportunities throughout your hunt, you will not hunt the last afternoon of your scheduled hunt. **Archery hunters:** You will hunt the evening of the day you arrive to camp and only hunt the last morning of your scheduled hunt, excluding hunts starting on Sept. 15th.

INCLUDED IN YOUR HUNT COST: H&A Outfitters, Inc. elk, deer and antelope hunts include professional guides – 1 guide per 2 hunters, lodging (excluding private ranch antelope hunts): arrive the day before scheduled hunt date and depart by the last day of scheduled hunt date, 3 meals per day (excluding private ranch antelope hunts), transportation during the hunt, and field care of your trophy – gutting, caping, skinning, and quartering. We will prepare antlers and the cape for the flight or drive home. Also included is 3% U.S. Forest Service tax and 3% BLM (Bureau of Land Management) tax.

NOT INCLUDED IN YOUR HUNT COST: Landowner authorizations are your option and your expense, New Mexico State license fees, New Mexico state gross receipts tax, taxidermy, meat processing, shipping of horns or antlers or meat. One non-hunter guest per hunting party is allowed at \$200 per day. This must be arranged no later than 30 days prior to your hunt. **Guide and cook gratuity.**

H&A Outfitters, Inc. is not responsible for changes in license fees, hunt dates or any other changes made by the New Mexico Game and Fish Department or changes made by the U.S. Forest Service such as mandated forest closures due to wildfires or other unpredictable occurrences. **If participant/client is under the age of 18, parent or guardian must sign on their behalf.** Having read this hunt contract entirely and understanding it completely, I agree to this hunt contract and terms.

Per NM State Regulation 19.30.8.12, this is a multi-year contract and it will need to be re-signed every three years to stay valid or it will be voided.
