SEMI-GUIDED HUNT CONTRACT

We require a \$100 fee. This will allow you to apply yourself for 4 consecutive years utilizing the outfitter's draw pool. After successfully drawing a tag or tags in the 10% outfitter draw pool, total hunt cost is due 15 days after draw release date. Upon drawing a license in the 10% outfitter draw pool utilizing H&A Outfitters, Inc. New Mexico registered outfitter number, your total hunt payment and state license is non-refundable. **WOUND POLICY:** Your guide will make every effort to locate your wounded trophy. It will be at your guide's discretion when to continue your semi-guided hunt. **You shall and will obey all federal and state laws while participating in your New Mexico hunt.** H&A Outfitters, Inc. has the right to use any or all of your hunt photographs for advertising and promotional purposes. All hunts are free ranging fair chase.

INCLUDED IN HUNT COST

H&A Outfitters, Inc. semi-guided elk and deer hunts include the use of our outfitter number for limited draw entries. Professional guide – one guide for 2 to 4 hunters for 2 or 4 days, whatever is agreed upon between outfitter and clients. An additional guide may be requested for groups of 3 or 4 hunters at an additional cost of \$850 per day. During your semi-guided hunt days your guide will scout proven ground 1 day prior to hunt date, guide for 2 or 4 days, and assist in field care and packing out your trophy on scheduled guided days only. After your scheduled guided days, clients can continue hunting on their own for the duration of their license. Also included is 8.5% New Mexico state gross receipts tax, 3% U.S. forest service tax, 3% BLM tax.

NOT INCLUDED IN HUNT COST

Landowner permits, New Mexico State license fees, camps/lodging, supplies, meals, transportation, taxidermy, meat processing, shipping of horns or meat, airport pickup.

H&A Outfitters, Inc. is not responsible for changes in license fees, hunt dates or any other changes made by the New Mexico Game and Fish Department or their lack of professionalism by some, while you are participating in your hunt in New Mexico. Any disputes which may arise between H&A Outfitters, Inc. and client arising out of the services provided herein shall be heard solely in the appropriate state of federal or district court within the State of New Mexico and irrevocably waive any objections either may have based on improper venue or forum non conveniens to the conducting of any proceeding in any court. Client agrees that New Mexico law shall govern the rights and liabilities of the parties, without regard to conflicts of law principles. **If participant/client is under the age of 18, parent or guardian must sign on their behalf.** Having read this hunt contract entirely and understanding it completely, I agree to this hunt contract and terms.
